All National TOA Federations, Representatives and Associate member of WUTA are kindly requested take clear notice of the following:

#### A) MANDATORY TERMS & CONDITIONS

1. All athletes must present the following documents to the WUTA Registration Committee on Sunday 6<sup>th</sup> November 2011 at Shiraz City, I.R. Iran.

**Original passport of each participating athlete and personal health declaration signed and stamped by a medical doctor stating that the athlete is physically fit to participate in the World TOA championship.**

2. Each National Delegation must bring with them and hand over to the WUTA Organizing Committee, a MP3 file of their national anthem.

3. Each National TOA Federation/Association is required to duly complete on INTERNET, the ONLINE Athletes Registration Form (see [www.wuta.org](http://www.wuta.org)) in ENGLISH, in capital letters and submit the same on or before **1<sup>st</sup> SEPTEMBER, 2011.** (Any Subsequent request of CHANGE of Details in the Registration Form etc., WILL NOT be accepted after the On Line Submission).

4. The rules of World Championship shall be as per the WUTA Rules of Competition as modified by the Executive Board in 2010 and all National Federations/ Associations must ensure that their athletes are properly trained under these rules and must have full knowledge of these rules in order to be eligible to participate in the World Championship.

5. When competing in any bout, all national athletes must be attired in the official WUTA uniform, which will be provided FREE OF COST by WUTA, for all eligible athletes, in the design and material as approved by the WUTA.

6. Outside the competition bout and venue, all athletes must be attired in their Official National TOA Tracksuit, which has to be arranged and provided by their respective National TOA Federations / Association. **All Female Participants are required to cover their hair with scarves at all times, in conformity to Iranian custom and tradition.**

7. All certified WUTA International Referees must be attired in official referees uniform with the WUTA official logo as provided Free of Cost by WUTA.

8. All National TOA coaches must be attired their National TOA Track Suits and white sports shoes, which has to be arranged and provided by their respective national TOA Federation.

9. Any participant, coach or referee, found NOT complying with the afore stated Dress Code Regulations, is liable to be removed from the competition venue.

10. All Participating National Athletes and Officials are expected to conduct themselves as goodwill ambassadors of their respective nation and abide STRICTLY by the laws and regulations and traditions of the Islamic Republic of IRAN and the city of Shiraz.

#### **B] CHAMPIONSHIP VENUE**

The World TOA Championship will be held at the Government Stadium in the city of Shiraz, Fars Province in I.R. Iran.

#### **D] PARTICIPANTS AIRFARE**

All National Toa Federations are expected and encouraged to participate in this championship with MAXIMUM number of male and female Athletes, in accordance to the weight categories and event categories. **WUTA is pleased to proclaim that it will provide each participating National TOA Federation with FOUR FREE return airfare Tickets to each participating National Federation, to enable specifically ONLY one National Coach, two male athletes and one female athlete, to travel from their National Capital to Shiraz, Iran and return.**

**Note: Apart from the aforesaid FOUR participants, the cost of return air fare for ALL Additional National Participants and Officials etc, have to be arranged and provided by their respective National Toa Federation. [Free Accommodation and meals and internal travel will be provided for all as already stated herein].**

### **E] MEDALS and CERTIFICATES:**

**One Gold, one Silver and two Bronze medals, with corresponding certificates will be awarded to the winners of each event category, as proclaimed herein. Apart from this, WUTA Participation Certificates will also be issued to non medal winning athletes, as well as for Referees, National Coaches and Officials. Meritorious Teams / Athletes will also be eligible for additional Valuable Prizes.**
